COMMUNITY BANK, N.A. OFFICIAL RULES

LIVERPOOL BRANCH GRAND OPENING BINGO PROMOTION ("Bingo")

- 1. **Prize.** Throughout the Promotion Period (as defined below), Community Bank, N.A. ("Community Bank") will distribute a bingo card to each eligible participant that completes the required entry steps described below to enter the Bingo promotion (the "Promotion"). Community Bank will give to each participant that completes a Bingo card as described in Section 3 below one (1) gift certificate to one of the businesses identified on the back of the Bingo card, each located in Liverpool, New York (valued at \$100) (the "Prize").
